Baycon 2000 Terms and Conditions of Participation

Dealers understand that Baycon provides a merchandising location for interested individuals/organizations. Baycon provides 1 (one) table and 2 (two) chairs per table space, and will provide electricity on request. Baycon does not provide telephone or telecommunications service, which is the sole responsibility of the dealer.

Baycon secures the dealers room to prevent unauthorized access between (approximately) 7PM and 9AM. Dealers understand that Baycon does not assume liability for shrinkage, theft, etc., but does make a good faith effort to prevent this problems in this regard.

Baycon specifically requires the following:

- A valid California resale number. You are not required to provide this at the time you apply for a table. You must, however, have a valid resale number on file with the dealer's room liaison when you register at the convention.
- A legal name for each badge you request. You may also, optionally, request a fan name be printed on the badge. You must provide, no later than registration at the convention, a proper name for each badge-holder, however.

Baycon does not allow the sale of pirate/bootleg material. Possession for sale of such material will constitute grounds for expulsion from the dealers room and convention without recompense, and may be referred for prosecution.

Registration Procedures

Baycon will release 65% of the Year 2000 dealer's room tables (total of 40) for sale at the convention, starting Monday morning. These will be sold on a strictly first-come, first-served basis, and require payment in full and submission of a completed and signed application. Any tables for which the dealer fails to properly pay (bounced checks, for example) will be immediately released for sale, and the dealer will be required to re-apply.

The remaining 22 tables will be made available for sale commencing July 1st. Requests for these tables will be accepted on a continuing basis, but they will be juried, with the intention of providing an opportunity for new dealers.

To apply for the juried selection, you must submit a completed and signed application, along with payment in full for your selected tables. This payment will be held in escrow until after the jurying is complete. Payments received from unsuccessful applicants will be returned in full, while payments from successful applicants will be deposited. It is your responsibility, if paying by check, to assure that valid funds are available for your check. Any tables for which the dealer fails to properly pay (bounced checks, for example) will be immediately released for sale, and the dealer will be required to re-apply.

Voluntary Withdrawal and Refunds

Baycon table purchases are made on a non-refundable basis. Where feasible, we will attempt to resell your table if you need to withdraw, and if such resale is successful, we will refund your fees in full. This is the only circumstance under which dealers can expect a refund.
